

## Entry requirements and admission criteria

### SOCIAL EDUCATION

#### Entry requirements and admission criteria

The Bachelor's degree in Social Education at the University of Deusto is open to any qualified person, without any discrimination on the grounds of age, sex, race, religion, disability, sexual orientation, ethnic or national origins or other status.

Access to this Bachelor's degree is made in accordance with the current legislation, contained in Order EDU/1247/2011, of 12 May, amending Order EDU/1434/2009, of 29 May, which updates the annexes of Royal Decree 1892/2008, of 14 November, which regulates the requirements for access to official university undergraduate degrees and the procedures for admission to state universities in Spain, as well as the Note issued by the General Secretariat of Universities on the procedures for admission to official Bachelor's degrees in accordance with the new regulations established by Organic Law 2/2006, of 3 May, on Education by Organic Law 8/2003, of 9 December, on the improvement of educational quality (LOMCE), issued on 3 April 2014. The legislation will be updated as it is amended.

In accordance with the current regulations, entry to this degree programme may be granted to those who are in one of the following cases:

1. Holders of a Baccalaureate qualification as referred to in articles 37 and 50.2 of Organic Law 2/2006, of 3 May, on Education.
2. Students from education systems of EU member States or other States with which Spain has signed International Agreements in this regard under Article 38.5 of Organic Law 2/2006, of 3 May on Education, who meet the entry requirements in their respective countries for access to the university.
3. Students from foreign education systems, prior request of recognition of the qualification in the issuing country as equivalent to the Spanish Baccalaureate qualification.
4. Holding a Higher Technical qualification corresponding to Vocational Training and Artistic Education or to
5. *Técnico Deportivo Superior* corresponding to the Sports Education referred to in articles 44, 53 and 65 of the Organic Law 2/2006, on Education.
6. Adults over twenty-five years of age, as provided for in twenty-fifth additional provision of Organic Law 6/2001, of 21 December, on Universities.
7. Those who provide evidence of having work or professional experience, through the procedure provided in article 42.2 of Organic Law 6/2001, of 21 December, on Universities, as amended by Law 4/2007, of 12 April, whereby the previous one is amended.

8. Adults over forty-five years of age, in accordance with the provisions in article 42.2 of Organic Law 6/2001, of 21 December, on Universities, as amended by Law 4/2007, of 12 April, whereby the previous one is amended.

Those meeting some of the following requirements may also be eligible for access to Bachelor's degree programmes:

- Holders of an official university Bachelor's degree or an equivalent degree.
- Holders of an official university degree including: *Diplomado universitario, Arquitecto Técnico, Ingeniero Técnico, Licenciado, Arquitecto, Ingeniero*, corresponding to prior university degrees or equivalent degrees.
- Students having studied but not completed their university studies abroad or in Spain, or who having successfully completed their university studies abroad have not obtained their recognition in Spain and wish to further their studies at a Spanish university. In this case, the university concerned must have recognised at least 30 ECTS credits.

## **SOCIAL WORK**

### **Entry routes and requirements**

The Bachelor's degree in Social Work is open to any qualified person, without any discrimination on the grounds of age, sex, race, religion, disability, sexual orientation, ethnic or national origins or other status.

As set out in the informative note of the General Director of Universities, of 23 May 2008, and while new regulations are not issued, requirements to access official Bachelor's degrees include holding a Baccalaureate qualification or an equivalent qualification, and having passed the test referred to in article 42 of Organic Law 6/2001, on Universities, amended by Law 4/2007, of 12 April, without prejudice to other mechanisms for access provided for by the current regulations. Therefore, the various entry routes and their specific requirements are maintained: *COU*, Vocational Training Programmes, Baccalaureate studies (*Bachillerato*) under LOGSE, Professional Training Programmes, access from European education systems, partial recognition of foreign degrees, access for adults over 25 years of age, etc.

In addition to the above entry routes, Royal Decree 1393/2007, of 29 October, in its fourth additional provision (point 3) establishes that those who hold an official diploma, technical architect or technical engineer degree and intend to take courses leading to an official bachelor's degree, will obtain the recognition of credits as provided for in Article 13 of this Royal Decree.

Taking into account this fourth additional provision, the University of Deusto offers a specific course for graduates in Social Work. The admission criteria for this programme are as follows:

1. Holding an official university Diploma in Social Work worth at least 207 ECTS credits. These diploma graduates obtained their degrees in University Schools of Social Work, once the previous schools of social assistants were incorporated into the university regulated by Royal Decree 1850/1981, of 20 August, on the incorporation of the social assistant studies into the University as University Schools of Social Work.
2. Holding a Diploma in Social Work. These diploma graduates obtained their degree through recognition of the Social Assistants diploma, by fulfilling the requirements established for this purpose and regulated in the Order of 8 May 1987, which developed the 2nd and 4th transitory provisions of the aforementioned Royal Decree.
